#### WHAT DOES INVESTORS TITLE INSURANCE COMPANY (ITIC) AND ATLANTIC CAROLINAS TITLE, LLC (ACT) DO WITH YOUR PERSONAL INFORMATION?

## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

# What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- social security number and transaction history
- purchase history and mortgage rates and payments
- checking account informationand wire transfer instructions

When you are no longer our customer, we continue to share your information as described in this notice.

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons ITIC and ACT Title choose to share; and whether you can limit this sharing.

What we do	
How does ITIC and ACT protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We will continue to enhance our physical, electronic and procedural safeguards as new technologies become available.
How does ITIC and ACT collect my personal information?	We collect your personal information, for example, when you: open an account or apply for insurance file a claim or provide your mortgage information show your government issued ID We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  ITIC affiliates include companies with an Investors Title name; financial companies such as Investors Trust Company; and nonfinancial companies such as Investors Title Management Services, Inc.	
Nonaffiliates	Companies not related by common ownership or control.  They can be financial and nonfinancial companies.  ITIC and ACT do not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  ITIC and ACT do not jointly market with nonaffiliates.
